## Administration

- 1) Village of Hustisford Dam - The Village, Federal Marsh and State Marsh will be working together this winter to slowly release water over their dams in coordination with each other. Drawdowns may start as early as December 15th as needed. This hopefully will help limit flooding downstream on farm lands. Chad has asked the Village for a detailed plan summary which will be reviewed to ensure that fish stocking is not compromised due to this change.

## Watershed Improvement

- 1) **County Update:** Andrew provided an update.
  - a) Fox Lake will have an ordinance in place for large wake boats. Informational meeting on October 26, 2024.
- 2) **Update on Healthy Soils/Water** by Joe and Chad. Chad noted that the Cover Crop Demonstration 9/26 event at a local farm with a follow-up gathering at Buchanan's went well. Mainly farmers attended. County still has cover crop money to distribute to farmers. Farmers can call John Bohonek or Robert Bryd - Dodge County.

## Lake Improvement Projects

- 1) Mike Mervis had an open house (at his house) on October 5 to demonstrate how the dredging material pulled from his shore dewatered, and then was planted with wildflowers. Chris and Joe attended. Nice turn out of neighbors.
- 2) USGS Water Level Monitor and Shoreline Mapping DNR Preliminary Grant Application was submitted and received by DNR by September 15, 2024. The detailed grant application will be submitted by November 15, 2024. .
- 3) Task force working on a preliminary dredge design contractor bid request. Task force will have more information for the Commission in November.

## Maintenance Projects

- 1) Website status: Nate London (from LSA) will attend the November meeting to answer questions on what he can do for us. The final decision on the direction of the website will be at the

December meeting.
